Parking Rules & Regulations

Kapiolani Business Plaza

1580 Makaloa Street, Honolulu Hawaii 96814

- 1. The parking facility is accessible during normal building hours, and also accessible during after hours by use of the building issued remote control device or access card. Unauthorized vehicles and any vehicle parked longer than 24 hours without the permission of Building Management may be towed at Owner's expense in accordance with Hawaii Administrative Rules and Hawaii Revised Statutes 290–11.
- 2. There will be <u>no</u> substitutions, vacation credit or prorated charges.
- 3. Monthly charges will be billed by Secure Parking Hawaii.
- 4. This Agreement licenses the holder to park one automobile in this area. Only a rental space license is guaranteed and no bailment is created.
- 5. Building Management retains the right to effect any change in rate, revise or amend rules and regulations, or discontinue parking agreements, with 30 days notice, subject to the Lease Agreement with Building Management.
- 6. Secure Parking Hawaii reserves the right to cancel the Parking Agreement without prior written notice if due payment is not received by the due date.
- 7. Unreserved Parking access from Makaloa St entrance: Please be advised that a \$5.00 activation fee will be applied for the provision of a parking access card. In the event of loss, theft, damage, or transfer of the parking access card, a fee of \$15.00 will be incurred. All requests for new or replacement cards must be submitted in writing to Secure Parking Hawaii. For security purposes, please promptly notify Secure Parking Hawaii of any lost, damaged, or stolen cards.
- 8. VIP Reserved Parking access from Kaheka St entrance: Please be advised that a fee of \$25.00 will be applied for the provision of a remote control device. In the event of loss, theft, or damage to the remote control device, a replacement fee of \$25.00 will be incurred. All requests for new or replacement devices must be submitted in writing to Secure Parking Hawaii. For security purposes, please promptly notify Secure Parking Hawaii of any lost, damaged, or stolen remote devices.
- 9. Safety precautions:
 - o Observe 5 mph speed limit.
 - Be alert to people crossing the traffic path.
 - o Do not leave valuables in the car and remember to lock car doors.
 - "Buckle Up" before leaving the parking facility.
 - Be alert to pedestrians crossing in front of the exit when leaving the parking facility.
- 10. Parking in Non-Designated Areas: Vehicles parked in areas not designated for parking create safety and traffic hazards and are subject to impoundment and/or towing at owner's/driver's expense.
- 11. Reserved Stalls: Stalls designated with a company or individual name are reserved 24 hours a day. Unauthorized vehicles are subject to impoundment or towing at the owner's expense. The impound fee is the current maximum all-day rate.
- 12. Towed Vehicles: Contact VIP Towing.



- 13. Limitation of Liability: Use of parking facility is at the user's risk. The Kapiolani Business Plaza expressly disclaim any liability for injuries to persons, including death, or damage to property, including theft or fire, which a person might suffer when using the parking facility. Under no circumstances shall Kapiolani Business Plaza be liable for consequential or indirect damages. The user hereby agrees to defend, hold harmless and indemnify The Kapiolani Business Plaza its employees and agents from any liability, claims, demands whatsoever, including attorneys' fees resulting by user or others for personal injury and damage created or caused from any negligent acts or omissions of users. The user agrees to name Kapiolani Business Plaza and the facilities located at Kapiolani Business Plaza as additional insured under the user's Commercial General Liability coverage.
- 14. Reports of Incidents: Property Damage and personal injury should be reported to Building Management. As a matter of security, please report any incidents of theft or suspicious persons loitering in the parking facility to Security as soon as possible.
